# Minutes of a Meeting of the NH Association of Fire Chiefs

Thursday, July 13, 2023 – Atlantic Grill, Rye, NH

The meeting was called to order at 1834 hours by Chief Best.

After a salute to the flag, a moment of silence was requested for departed members.

Chief Cotreau welcomed all to Rye. He introduced Lt. Kevin Wunderly of the Rye Fire Department as his guest.

#### INTRODUCTION OF MEMBERS.

Robert Duval, Regional VP for NFPA spoke of this year's Fire Prevention Week theme and upcoming programs available from NFPA.

## President's Report: (Best) -

 Primex Public Safety Chiefs' Forum for 2024- we are interested and ED Lemire will be the contact

- Appointment of NHAFC President (or designee) to committee on Recruitment and Retention. He will take the position and appoint a designee.
- North Country Public Safety Awards Banquet table sponsorship and ad in book was authorized by the board. Banquet will be held on November 10, 2023.
- Strategic Plan overview will be held in August.
- Insurance Commissioner Bettencourt is attempting to begin a process of getting EMS providers and insurance carriers into good faith negotiations to get innetwork with one another. If it can be accomplished there would be no need for HB 373.

## **Executive Director's Report (Lemire)**

- The August 2 (Wednesday) board meeting will be in Litchfield.
- The regular meeting on the 10th will be in Gorham at the Town and Country Inn and Resort.
- The September 14 meeting will be at the LRCC and includes breakfast.
- October meeting will be virtual at this point.
- Dep. Maurice Paquette's appointment to the Emergency Medical and Trauma Services Coordinating Board has been confirmed by the Executive Council.
- The Lakes Region Community College has announced that Senator Shaheen has secured a grant for the college to provide up to \$8,000 in tuition scholarships for two years to those qualifying students enrolled in the paramedic program. More info will follow.

**1st Vice President Report (Emanuel**) – no report but our lobbyist submitted an update.

Included with the update is a legislative chart which contains all of the bills which NHAFC monitored during the 2023 session. Not all of the bills that have passed the House and Senate have been acted upon by the Governor. Once they reach his desk, he will have 5 days to decide whether to sign, veto, or let a bill become law without his signature. The process of getting all the bills through the process will likely take the remainder of the summer. A veto session day will likely be scheduled for the fall at which time the House and Senate will vote whether to override the vetoes or not.

When you get a chance to review the chart, you will see that a number of bills were "Retained" in the House. House policy committees will meet in the late summer and fall to further examine these bills. By Friday, November 17, House Committees must issue traditional committee reports for the House to consider in early 2024. The Senate will likely use a less formal process, called "Re-referral". The Senate deadline for reporting re-referred bills is Thursday, December 14.

The House has set the filing period for 2024 legislation for September 11 through September 15. The Senate period for filing legislation will run from September 28 through October 12.

- **HB 2 (budget trailer bill)** The NH state budget is comprised of 2 bills, HB 1 which includes traditional budget line items and HB 2 which includes all the changes to law necessary to implement the budget. In prior updates, we explained that it was unclear if the language from HB 436 would remain in the final version of HB 2. HB 436 was the bill to eliminate the "middle tier" in Group II. The language was put in HB 2 by the House but was removed in the Senate. The final version, which was signed into law in late June, did **NOT** include the language. Instead, it was replaced with a "Retirement Benefits Commission" which is expected to review this issue, and others. The final version of the budget did include an increase Medicaid rates for ambulance services as well as funding to create a law enforcement, professional firefighters, and EMT career development, recruitment and retention program. The language is similar to SB 153 which NHAFC supported earlier this year.
- **SB** 71 (Workers' Compensation for Firefighters with Cancer) The House and Senate have both passed the bill. It is making its way to Governor Sununu. The final version of the bill did not include a proposed study commission but it did include language which allows for workers' compensation for firefighter cancer disease of all types.
- **HB 296 (Driveway permits)** The bill has passed the House and Senate. Governor Sununu will have it reach his desk before too long. The final version of the bill stated that the state fire code and associated rules shall not supersede local planning and zoning boards for driveways for detached one and two family dwelling units. Minimum driveway width cannot be less than 12 feet for driveways 150 feet or longer. Prior to any land use board approval, the boards shall give due consideration to written comments from the local fire chief.
- HB 461 (Elimination by Political Subdivision Employers of a Retirement System Position) The House version of the bill would have required political subdivisions to obtain an analysis from the retirement system and continue to pay unfunded accrued liability contributions when eliminating or transferring an employment position from full time to part time. The Senate version created a study committee (1 Senator and 4 House members) which would "...study the elimination by political subdivision employers under RSA 100-A of a retirement system eligible employment position." The bill went to a committee of conference for both sides to develop agreement. No agreement was reached and the bill was killed.
- **HB 373 (Ambulance Billing)** This bill sought to prohibit "balance billing" for ambulance services. NHAFC and a number of ambulance providers testified against the bill at the initial hearing earlier this year. The bill has been retained in the House Commerce Committee. NHAFC will likely need to participate in additional committee work sessions on the bill later this fall.
- **HB 182 (Volunteer Firefighter Employment Protections)** This is the bill which intended to provide employment protections to volunteer firefighters

who may not arrive to work on time due to a call response. The House Labor Committee retained the bill. During a recent work session on the bill, committee members appeared to coalesce around developing new language which would mirror existing law dealing with EMTs. It would allow for volunteer firefighters to stop at a scene if they were passing it en route to work. The committee will meet again later this summer/fall to review language and discuss it further.

HB 296 relative to local authority for granting driveway permits

Status: Passed House & Senate, waiting on Governor's signature HB 564 relative to ratification of amendments to the state building code and state fire code

Status: Signed into law by Governor

SB 54 permitting the use of certain refrigerants that are in compliance with the Clean Air Act

Status: Passed House & Senate, waiting on Governor's signature

#### **Board of Fire Control:**

The Board of Fire Control and the SFMO staff have started the review of the 2021 editions of NFPA 1 and NFPA 101. The goal is to have a package ready for legislative action in 2024. A public hearing will be held on September 20th to address amendments.

## **BUREAU OF INVESTIGATIONS:**

In the month of June, we received 15 incident notifications resulting in 2 scene responses. The Bureau of Investigations currently has 21 open arson or suspected arson investigations.

#### New cases (synopsis of some of our cases are listed below):

- On June 28, 2023, investigators responded to an untimely death in Salem suspected to be caused by carbon monoxide poisoning. This was a natural death and not a result of CO.
- On June 30, 2023, investigators responded to a fire in Raymond that appears to be incendiary. This investigation is ongoing.

#### Ignitable Liquid Detection Canine Teams:

- There was 1 IGL canine deployment in June.
- IGL canine teams performed 5 demonstrations.

## Youth Firesetter:

• There were 0 youth fire setter assessments and 3 inquiries in June.

#### Court:

 On June 15, 2023, an investigator testified in front of a Strafford County Superior Court Grand Jury regarding an arson that had occurred on June 28, 2022 in Dover. The testimony provided resulted in the indictment of Mr. Sean Rutherford on a Class B Felony arson charge.

## Hazardous Materials:

Hazardous Materials response, coordination and consultation is available through the oncall FMO

supervisor. Our Hazardous Materials Coordinator is available for PEAC Software training for fire

departments. PEAC is used for documentation of Tier II facilities and chemical storage.

In the month of June, our Hazardous Materials Coordinator attended the Carroll County Haz Mat Team reorganization meeting. He also attended the Midwestern Haz Mat Team training focused on the Unknown Substance Protocol and the Southeastern Haz Mat Team's training on air monitoring in confined space rescue.

We continue to work on Tier II reporting and associated follow-ups when deficiencies are identified.

Our Hazardous Materials Coordinator attended the Haz Mat Collaborative meeting and continues to work with the teams to schedule a grant funded air monitoring training class. He also attended the quarterly SERC meeting, held on June 15<sup>th</sup>, as well as the IAFC Hazardous Materials Response Team Conference in Baltimore, MD.

## Swiftwater Rescue Working Group:

Further discussions and work is ongoing to evaluate the swiftwater problem and funding sources.

## Regional Outreach/Chief's Roundtables:

We continue to partner with the Commissioner's Office, other Department of Safety Leadership and the NHAFC to conduct regional outreach/Chief's Roundtables.




2022 Fire Incident Type by Category:

## **Outreach Events:**

On June 1, 2023 members of the SFMO had the pleasure of attending the Special Olympics of NH Summer Games at the University of New Hampshire. Members staffed a fire safety table and handed out medals to participants. This is one of our favorite events to attend and we love seeing the excitement and pride on the athletes' faces!



Also on June 1, 2023, members of the SFMO attended the New Hampton Public Safety Day. We handed out fire safety education, tested fire safety knowledge with our trivia wheel, and provided canine demonstrations.



Members of the SFMO also attended the Hebron Fire Department's 75<sup>th</sup> Anniversary Celebration on June 10<sup>th</sup>. Members also presented a basic fire investigations and NHFMO overview at the Laconia High School Regional Technical Center, NH Emergency Services Explorer Academy and the NH Police Cadet Training Academy. Members also provided a static display of our cruisers, equipment and K9s for the NH Police Cadet Training Academy.

On June 20, 2023, Director Sean Toomey and Nashua Fire Chief Steve Buxton presented Jose M. Pichardo of Nashua, NH, with the Carnegie Medal Award. The Carnegie Medal is a prestigious award, considered one of the highest civilian honors in the U.S. and Canada. The recipients of this are civilians who knowingly and voluntarily risk death or serious physical injury to an extraordinary degree to save the life of another person. On October 1, 2021, Jose was driving home from work when he saw flames coming from the back of a home. He jumped into action and rescued the 97-year-old occupant of the home. Both suffered smoke inhalation and were treated and released in the following days. We would like to congratulate Jose on being recognized for this esteemed and well-deserved award! He is the fiftieth recipient to receive this award in New Hampshire.

The scope of this fundamental-level course looks at the following as the primary guidance for the approval of residential sprinkler systems: National Fire Protection Association (NFPA) 13, Standard for the Installation of Sprinkler Systems, NFPA 13D, Standard for the Installation of Sprinkler Systems in One- and Two-Family Dwellings and Manufactured Homes, NFPA 13R, Standard for the Installation of Sprinkler Systems in Low-Rise Residential Occupancies, International Residential Code Standard P2904, Manufacturer's Data Sheets. The ability to read and interpret the design is an essential element of preventive fire safety.

# <u>Fire Standards/Training/EMS</u> – (Director Cutting) ADMINISTRATION

#### Personnel

- ➤ Danny Gerlack has been hired for our open full-time Fire Service Instructor Supervisor (Captain) position in the Bureau of Fire Training and started on June 30<sup>th</sup>. Captain Gerlack comes to the Division with twenty-six years in the fire service and over twenty-years of leadership and supervisory experience in the private sector.
- ➤ Nick Bibeau has accepted the position of Fire Service Instructor Supervisor in the Bureau of Certification and Support and will begin on October 6<sup>th</sup>. Mr. Bibeau currently works for the Division in the Bureau of EMS, has previously worked for NH Homeland Security, and has ten years of fire service experience in his community.

- ➤ The remaining open Fire Service Instructor Supervisor position in the Bureau of Certification and Support has been advertised for candidates.
- ➤ We have two vacancies for Program Specialist III (Education Technologist) of the Educational Technology section of the Division and we have advertised the positions for candidates. An offer has been made to one candidate.
- > We have one part-time Compliance Specialist position open and will be conducting interviews soon.
- > Our part-time Program Coordinator positions for Fire Officer, Promotional Coordinator, Instructor, Hazardous Materials, Swift Water and EMS Initial Programs are open and we are seeking applicants.

#### **Grants**

- ➤ We have been awarded \$476,186 for the 2022 AFG that was submitted. This will fund 50 additional sets of structural PPE, EMS simulation training equipment, a tow vehicle, trailers, saws, ladders, hose, a PPE washer/extractor and gear racks.
- ➤ The architectural firm retained for the Raymond S. Burton Fire and EMS Training Facility project is proceeding with obtaining necessary permits and completion of the construction documents in preparation of advertising the project for bids.
  - Land clearing is expected to begin this fall/winter with site work starting in the spring of 2024.
- ➤ We continue to work with the Department of Health and Human Services Covid Disparities Funding program to expand Image Trend to add Continuum, additional IFT, MIH and simulation training and staff support.
- ➤ We have not yet received a response on our application for a grant for \$471,000 through the Workforce Innovation and Opportunity Act funding available at the Department of Business and Economic Affairs to fund a comprehensive campaign designed to recruit firefighters and EMS providers in our state.
- ➤ The NH EMT Training Program remains active with grant funding for training new and existing EMS providers. Contact our Division or NH Employment Security for details and question.

# Fire Standards and Training Commission / Curriculum

- ➤ The next Fire Standards and Training Commission meeting will be September 7<sup>th</sup> at 0930 in Classrooms 5/6 in the dormitory building at the main campus. The full schedule for 2023 also includes a meeting November 2<sup>nd</sup>.
  - The Fire Standards and Training Commission has approved the written comment period to open through July 19, 2023 for public comment on the proposed changes to the following curriculums: Rope Rescue Awareness, Operations and Technician. - The Fire Standards and Training Commission is seeking individuals who are interested in participating in a Visiting Committee to evaluate the Hazardous Materials Awareness, Operations, Decontamination & Technician programs in New Hampshire. ## Special Projects

- ➤ We conducted an Online Program Evaluation of our programs and have completed the redesign of course content with an improved student experience through updated navigation, orientation, a timeline feature, periodic exams, instructor and course evaluations, an announcements feature and feedback option for students.
- ➤ We are working to link the online platform and RespondNH which tracks courses on student transcripts. Students will be able to directly self-enroll into any of the online Firefighter I and II modules and achieve completion. A State instructor will then be able to CREF the skills portion, conduct the training, submit the course completion paperwork, along with student applications, to achieve completion of a module. After a student completes all modules they would be eligible for certification testing.
- ➤ Work is being done to renew our Division metrics and reporting.
- ➤ Work has begun on an improved capital planning and equipment replacement process.
- ➤ We continue to work with the NFPA on a train-the-trainer program for the EV Training Program to be hosted in New Hampshire.
- ➤ We have begun the planning process for our website transition and improvements with NH DoIT.
- ➤ We are working to support the New Hampshire Fire and EMS Committee of Merit and the annual awards ceremony will be held on Sunday, September 17<sup>th</sup> at the Capital Center for the Arts at 1330.

#### **Facilities**

➤ The "B" building upgrades that are needed have begun and should be completed this month.

➤ We are working on the replacement of two AC condenser units in the older portion of the dormitory building. The bid process, issuing of contracts and Governor and Council approval are anticipated this fall.

## Legislative/Administrative Rules

- ➤ HB 2 included the establishment of the Law Enforcement Officers, Professional Firefighters and Emergency Medical Technicians Career Development, Recruitment and Retention Program in New Hampshire RSA 188-F:70 with an appropriation of 1 million dollars to support the program. The program includes the creation of a committee to establish criteria and procedures related to awarding funds for tuition reimbursement which includes the Commissioner of Safety, or designee, as Chairperson, and the Director of Fire Standards and Training and EMS, along with others representing other groups and disciplines. The first meeting will be scheduled soon.
- HB 2 included changes to the administration of Naloxone. Effective July 1, 2023,
  the First Responder Naloxone Provider License will no longer be required for any
  individual administering naloxone and all current licenses will expire on this
  date. Training continues to be available through several resources, including our
  Division's online portal, to receive training on how and when to use the
  medication.
- ➤ The Fire Standards and Training Commission amended Fire rules relative to the Recruitment and Retention report and its recommendations are working through the internal legal process in preparation for submission to the Joint Legislative Committee on Administrative Rules which will include public input.

## Outreach

- ➤ We are continuing our Leadership Roundtables with the Commissioner, Fire Marshal's Office, HSEM and Emergency Services and Communications with regional Fire Chief's and EMD's.
  - Souhegan Mutual Aid group is planned for September 13<sup>th</sup>.
