# Minutes of a Meeting of the NH Association of Fire Chiefs

Thursday, February 8 – NH Fire Academy.

The meeting was preceded by a seminar on Municipal Cyber Security co-sponsored by Primex and NH Homeland Security.

The regular meeting was called to order by Chief Emanuel at 1112 hours.

After a salute to the flag, a moment of silence was requested for departed members.

President's Report: (Emanuel) –

<u>Tuition Reimbursement Program for First Responders</u>

The State of New Hampshire is working to support the career development, recruitment, and retention of emergency response personnel working in the Granite State with the tuition reimbursement program for first

Eligible first responders can take a course at any of New Hampshire's community colleges, including courses offered by CCSNH online. The program covers tuition and required fees for one course per semester, subject to eligibility and available funding. Participating employees will be certified as eligible by their employers and will be reimbursed upon successful completion of the course (completing the course with a grade of C or better). <u>Lithium Ion Battery/EV State Workgroup:</u>

The group was not able to meet in January. NHAFC recommended is for us to focus on impact on the built environment such as location of charging stations and storage of units. There is pending legislation to establish a State level commission to work on this project.

<u>Durham experienced a lithium-ion e-bike incident at UNH on January 24, 2024</u> The duty crew spent one hour at the residence hall ventilating and five hours at the scene of the secondary fire behind the University police station.

Lessons learned from our lithium ion/EV training this past fall at Dover High School was valuable to responders. The training and lessons learned paid dividends. Contributing Critical Actions Leading to the Successful Outcome:

- 1. E-Bike was being stored in a bike room (not a living space)
- 2. Devine Hall is a fully alarmed and sprinkled non-combustible building with fire extinguishers
- 3. Bystander extinguished the fire and activated the fire alarm
- 4. E-Bike was promptly relocated to the outside
- 5. Clear communication between responders
- 6. Remains of the e-Bike were stored outside in preparation for the secondary event

Fire Department Concerns & Discussion Points:

- Device permitting listed devices on campus
- Designated device charging and storage areas
  - Alarmed and sprinkled with fire doors
  - Adequate electrical support for charging
- Educational information
- Policy direction residents and responders
- Multi-department coordination
- Plan for secondary fire incidents and containment for post-incident materials/equipment
- Adequate inventory of packing materials for post- incident storage disposal of remains
- Designated storage areas for post-incident materials
- Replacement and/or reimbursement for equipment, supplies, and disposal

- For May, we will partner again with Primex for our meeting during their annual conference in Portsmouth May 15 16. Our meeting is Thursday the 16<sup>th</sup>.

- July 11 we'll be at the Academy for a breakfast meeting.
- August 8 we'll be at the Town and Country Inn in Sherburne/Gorham with a seminar.

- Also, on January 24, the Board of Directors took an email poll with the results as follows: A MOTION (Fraitzl/Chamberlain) to have the board send a letter of support for the renomination of Fire Marshal Sean Toomey carried unanimously. The letter was sent to the Governor and Commissioner on January 26.
- Also, on January 3, the board took the following action: A MOTION (Buxton/Thomas) to nominate Chief Ben LaRoche to the board to fill the Combination position, carried unanimously. Welcome to the board Ben!

Chief Tice summarized the report from the Director Cutting for the Professional Development Committee. The reports is as follows:

• The Professional Development Committee has met numerous times to identify training topics for the NHAFC. In early January we conducted a survey of the membership to solicit topics most important to focus on from their perspective. John Steere has contacted member Chief's from the northern part of the state to identify specific needs they have as well. He has spoken with three of them so far, received specifics topics, and gotten great feedback on making contact with them directly.

The top areas identified were leadership challenges, the fire chief as a change agent, recruitment and retention, middle officer development, developing and maintaining positive relationships from the fire prevention and enforcement perspective, using effective public relations and motivating/inspiring the workforce. Of those surveyed 12% prefer virtual training, 36% prefer in-person and 56% want a mix of both.

We sought to develop a plan through 2025 in an effort to advertise topics to be presented and to ensure funding is available when needed.

We would ask the Board to consider increasing the training budget to 3-5K to cover expenses related to speakers/presenters. Additional costs may be supplemented through registration fees/sponsors for the longer events including the annual meeting and the fall meeting historically held for a weekend.

We continue to meet and develop new topics and identify the best presenters for each. The committee is passionate about this and very engaged. We appreciate the opportunity to serve in this role.

1st Vice President Report (Watkins) –

**Government Relations – (Schmidt) –** (submitted in writing)

- Ambulance Billing Issues There are several bills dealing with ambulance reimbursement. SB 409 (Medicaid Re-imbursement for Treat/No Transport) the bill would require NH DHHS to file a Medicaid plan amendment which, under specific circumstances, would allow for re-imbursement for instances where an individual was treated, but not transported, to a hospital. Chief Mike Sitar attended the hearing and testified in favor. The bill passed the Committee and is headed to the Senate floor on Thursday. HB 1081 and SB 407 (Direct Pay) Both bills would require insurance carriers to pay providers directly, regardless of whether or not they are in network. HB 1081 was heard by House Commerce and should have a subcommittee soon. SB 407 includes additional provisions regarding payment rates, in addition to direct pay requirements. The hearing is scheduled for February 7. Chief Hunter will present testimony in favor.
- **HB 1647 (Group II Retirement Reforms)** The bill is a result of the Retirement Benefits Commission which met last summer and fall. It would adjust the retirement annuity multipliers for members who started service before 7/1/11 that were not vested by 1/1/12, and those who were hired after 7/1/11, to 2.5% per year for service in excess of 10 years. The bill appropriates almost \$56 million to cover the majority of the costs with this change. NHAFC will be submitted testimony in support of the bill. The House Executive Departments and Administration Committee is scheduled to vote on the bill on February 7.
- SB 352 (Retired and Full Time Firefighter Cancer Screening Program)

   The bill would create a \$5 million fund from which re-imbursements to retired and full-time fight fighters could seek re-imbursement, up to \$1,300, when specific documentation is provided. NHAFC, PPFNH, and Fire Standards and Training would be responsible for development of an initial plan to implement the screenings. The plan would be submitted to the Governor and Commissioner of the Department of Safety. NHAFC signed in as supporting the legislation. The bill passed the Senate Health and Human Services Committee 5-0 and is headed to the Senate floor on February 8.
- **HB 1352 (PFAS in station wear/PPE)** As introduced, the bill would require Fire Departments to "...give preference" to PPE which does not include PFAS, once those alternatives are made available. In the interim, Fire Departments shall have in place a policy that limits unnecessary exposure to PPE. Language is included that states it would remain a best practice from PPE to be used while operating in a dangerous environment. Regarding station wear, by January 1, 2025, Fire Departments shall not provide as an option any station wear that contains intentionally added PFAS or fire resistive chemicals (fluorine, chlorine, bromine, lead, or antimony). Manufacturers are required to provide safer alternatives, should they exist. The bill was requested by PFFNH. NHAFC and PFFNH had several discussions regarding implementation, should the bill pass. At the hearing January 30, PFFNH suggested that the language requiring preference being altered. It could be read to create an unclear mandate. Some of the members of the House Executive Departments and Administration

Committee had a few unrelated questions regarding the station ware language. A subcommittee will likely be held soon.

Special Committee on Housing – In 2023, the House created a committee to examine barriers to the creation of additional housing units. As housing became a critical issue for the state, the Committee spent a year receiving testimony from developers, regulators, municipal officials, and many other interested stakeholders. On Friday, February 16, the Committee will be hearing 7 bills that were developed by the special committee. There are two we wanted to highlight since they would be of interest. **HB 1065** would expand the existing sprinkler prohibition to include existing residential buildings with no more than 4 units, so long as the building is in compliance with the state fire code (including but not limited to fire barriers, dedicated ingress/egress, and monitored fire alarm systems). Previously, the sponsor has highlighted the costs associated with sprinklers when converting an existing residential building into several smaller units, within the same building envelope. **HB 1215** proposes that codes that were applicable at the time of plat approval, site plan approval, and building permit issuance would be the codes that the project would be required to meet. The intent appears to ensure that changes in codes do not alter plans and create unexpected costs and compliance challenges. At the same time, the bill does not reference any exemptions or time references. There are many concerns from entities representing land use regulators regarding the impact and potential challenges with implementation. The bill includes the fire code.

# **Board of Fire Control:**

The Board of Fire Control met on January 17, 2024. Everything is submitted to the legislature to update the State Fire Code to the 2021 editions of NFPA 1 & 101. We will likely see the Senate bill heard the week of February 12<sup>th</sup>. The next meeting will be on March 20, 2024.

# Foam Take-back Program:

The contract for the foam take-back program was approved by the Governor & Executive Council at the end of June 2023. DES has updated that they are now working on some facility disposal items with the vendor and anticipate the program remaining in a delayed status until late spring.

# **Strategic Planning Initiative:**

Our office has worked over the past few months to develop an updated strategic plan which will be part of an overall Department of Safety plan. The high-level goals for the office include accreditation, development of a statewide community risk reduction program, employee development, development of a statewide hazmat strategic plan, and facility/office space enhancement.

#### **BUREAU OF INVESTIGATIONS:**

In the month of January, we received 21 incident notifications resulting in 13 scene responses. The Bureau of Investigations currently has 19 open arson or suspected arson investigations.

# New cases (synopsis of some of our cases are listed below):

- On January 1 investigators and a K9 team responded to Troy for a fire in an old mill. The investigation is ongoing.
- On January 1 investigators also responded to a structure fire in Peterborough and determined it was an accidental fire.
- On January 5, investigators responded to Rochester for a structure fire. The investigation is currently ongoing.
- On January 8, investigators responded to Tuftonboro for a structure fire. The fire originated in a garage and the cause was undetermined but probably electrical and accidental.
- On January 12, investigators assisted Manchester Police and Fire Departments with a motor vehicle fire involving a stolen vehicle. This was an incendiary fire.
- On January 13, investigators assisted Epping Fire Department with a large fire involving several fuel tankers. The cause was attributed to a vehicle issue and was accidental.

- On January 15, investigators responded to a structure fire in Grantham in which one person was burned. The cause is suspected to be a wood stove and the investigation is ongoing.
- On January 18, investigators responded to a structure fire in an apartment building in Sunapee. The investigation is ongoing.
- On January 22, an investigator responded to a structure fire in Canaan that was caused by an electrical issue and was accidental.
- On January 24, investigators responded to Wilmot for what was initially reported as a barn fire. The owner had demolished the barn and set fire to the pile without obtaining permits.
- On January 26, investigators responded to a structure fire in Lee. The cause is undetermined and still under investigation.
- On January 30, investigators were notified of a structure fire that had occurred in Barrington. The investigation was delayed as part of a coordinated effort between FMO personnel and Barrington Police and Fire Departments and was conducted on February 1st. Barrington Police had made a non-fire related arrest as part of this case. The fire was caused by combustible materials in contact with heating elements on the kitchen stove. The investigation is ongoing.

# Fatal Fire/CO Incidents:

There was one fatal carbon monoxide incident in January. On January 16, investigators responded to Laconia to investigate an unattended death that was later determined to be carbon monoxide poisoning attributed to the operation of an unvented diesel heater within a structure.

# **Ignitable Liquid Detection Canine Teams:**

There was 1 IGL canine deployment in January.

#### **BUREAU OF OUTREACH & EDUCATION:**

#### **Hazardous Materials:**

Hazardous Materials response, coordination and consultation is available through the on-call FMO supervisor.

Our Hazardous Materials Coordinators are available for PEAC Software training for fire departments. PEAC is used for documentation of Tier II facilities and chemical storage.

In the month of January, our Hazardous Materials Coordinators attended the Haz Mat Collaborative Meeting, the PEAC monthly training, a training with Hazard 3 on emerging threats for 2024, held the quarterly SERC meeting, presented part of the EPA Tier II reporting webinar, and attended the Southeast Haz Mat Team drill on January 17th. In addition, they met with the Seacoast Haz Mat Team to discuss incident cost recovery. They also worked on Job Aids for Li Batteries and RAD Response.

Also, in the month of January, we received 69 Tier II reports from NH facilities. We also responded to 12 questions from facilities regarding Tier II reporting. We responded to two incidents, a Li battery fire involving an E-Bike in Durham and a RAD detection response at a waste facility in Concord.

#### Electric Vehicles and Lithium-Ion Batteries

We have held three meetings to discuss the challenges of electric vehicle fires and lithium-ion batteries. The meetings have included representatives from the State Fire Marshal's Office, Fire Academy, HSEM, State Police, DMV, DES, DOT, Tow Association, Auto Dealers Association, Clean Energy NH, NH Chiefs of Police and the NH Association of Fire Chiefs.

The International Code Council has established an ad-hoc group to evaluate building and fire code impacts from electric vehicles and lithium-ion batteries. The National Fire Protection Association Research Foundation is conducting a study. UL's Fire Safety Research Institute (FSRI) is also conducting a study. UL FSRI has additional information and resources for first responders here: Safeguard the future of Lithium-Ion Battery Devices with FSRI (batteryfiresafety.org).

We continue to partner with the Commissioner's Office, other Department of Safety Leadership and the NHAFC to conduct regional outreach/Chief's





#### 2023 NHFIRS Data:


Incident Type Category Summary

**NH Drug Overdose Commission – (Chief Thomas)** – He described the outcomes of their meeting last week. Overall drug overdose deaths are down.

## NH Information Analysis Center – (James Heinz-liaison) –

(U) **Cyber Attacks – Municipal Water/Wastewater Systems**: The NHIAC is aware of several successful cyberattacks on municipal water and wastewater systems nationwide. We encourage

you to be in contact with your water and wastewater partners to ensure sufficient fire flow in case of an emergency. <sup>1</sup>

- (U) **Household Hazardous Waste/Explosives Precursor Chemicals:** The NHIAC would like to remind you that household hazardous waste (HHW) collection sites offer access to explosives precursor chemicals (EPC). Recent products published by the EPA and FBI advise of the potential for HHW and EPCs. The management of HHW programs varies, leading to a wide variety of security measures. The prevalence of waste exchange areas and lack of consistent security, safety measures, and protocols at HHW collection sites enable individuals to obfuscate acquisition of EPCs (NHIAC, EPA.gov), <a href="https://www.epa.gov/hw/household-hazardous-waste-hhw">https://www.epa.gov/hw/household-hazardous-waste-hhw</a>
- (U) **UAS/Drone Activity:** The NHIAC is interested in drone activity conflicting with Fire/EMS operations. Please report any incidents of UAS (drones) flying or hovering around your emergency operations or fire stations, particularly in a reconnaissance type of behavior, to Law Enforcement or your Fire Service Intelligence Liaison James Heinz at <u>James.B.Heinz@dos.nh.gov</u>. - (U) **Stolen FD Extrication Tools Used in Crimes:** The NHIAC continues to receive information from the Maryland Fusion Center regarding the use of stolen fire department extrication tools being used to commit crimes needing power tools. Several recent examples include bank ATMs being breached by hydraulic jaws. Thieves use 'jaws of life' to pry open ATMs (msn.com)
- (U) **Operation Flashpoint:** A memo has been sent out in a few editions of the NHIAC monthly Fire/EMS Bulletin regarding Operation Flashpoint. The awareness campaign was developed in partnership by FBI and DHS. See this link to review the program overview and objectives Operation Flashpoint Program | CISA. Members of the NHIAC will be out in NH communities working with businesses on bomb making materials awareness. As we all know, some of the materials used in the Boston Marathon bombing were purchased locally. An educational and informational program has been developed and is being presented which includes visual aids and informational sessions by members of the NHIAC.
- (U) The NHIAC is an integrated, all-crimes/all hazards information sharing network that analyzes and disseminates information to engaged stakeholders from a variety of sources. - (U) The NHIAC is aware of several incidents involving fire in the vicinity of critical infrastructure facilities or assets. In an era of aging infrastructure and attacks targeting infrastructure, the NHIAC respectfully requests sharing of information and reports of incidents related to critical infrastructure, whether the
