Minutes of a Meeting of the NH Association of Fire Chiefs

Thursday, March 14 – Alan's of Boscawen.

The regular meeting was called to order by Chief Emanuel at 1858 hours.

After a salute to the flag, a moment of silence was requested for departed members.

Welcome from Host: Chief Emanuel welcomed everyone to the meeting.

INTRODUCTION OF MEMBERS.

Special Guests: Commissioner of Safety Robert Quinn and former Commissioner of Safety John Barthelmes.

Commissioner Quinn thanked everyone for the invitation and for their support and friendship. He introduced the members of his team (Directors Buxton, Cutting, Doyle, and Brian Allard) and shared the efforts of the team in the several projects that will be upcoming. He mentioned a new E-911 center, Interoperability, North Country Academy improvements and upgrading of the building codes. He shared how grateful he is for the work that they are doing.

Minutes: A MOTION (Fraitzl/Thomas) to approve the minutes of the February meeting, carried unanimously.

Treasurer's Report: February report will be presented next meeting.

President's Report: (Emanuel) -

- He thanked the Commissioners for attending and also for their support.
- He appointed a Nominating Committee and they will be presenting their report at the Annual Meeting (Chiefs Lyon, Cloutier and Coutreau).
- He also appointed an Audit Committee (Thomas, DeAngelis and Coutreau)
- He mentioned the efforts ongoing with Recruitment and Retention.

Report of the Executive Director: (Lemire)

- Our next BOD meeting will be at Primex in Concord on April 3 in the Brookside Room. THE MAIN ENTRANCE IN NOW OPEN AGAIN.
- The April Annual Meeting will be at The Common Man Inn and Spa in Plymouth. They have the space needed for the seminar, vendor showcase, meeting and dinner on April 11. To date, we have 20 vendors signed up and enough sponsorship to almost pay for expenses. Former Boston Fire Commissioner Joe Finn (Leading Change) and Dr. Nicole Sawyer (Psychology of Change) will be our seminar presenters.
- Our May BOD meeting will have to be on the 8th and virtual as we'll be in DC on the 1st.
- For May, we will partner again with Primex for our meeting during their annual conference. Our meeting will be at 3:00 pm on May 16 in the Warner Room of the Sheraton Portsmouth Harborside Hotel.
- The June 13 meeting will be virtual and held at 4:00 as to accommodate some of our part-time members.
- The July 11 meeting will be a breakfast meeting at the NHFA. The vendor has lowered their prices so we're back to \$16.00.
- On August 8, we'll join our North Country brethren at the Town and Country in Gorham (Shelburne) where we'll have a seminar being developed by the Professional Development Committee entitled "How to Effectively Manage Fire Prevention and Inspections through Building Positive Relationships." Overnight guests will be offered a discounted rate.
- August 12 is the date for our annual Golf Tournament at Lochmere in Tilton.
- Ad book proceeds to date: Total: \$3700.00, Vendor: \$2590.00, Assn: \$1110.00.
- Finally, several of you have asked about another November Professional Enhancement Weekend. I have a proposal from the "Snowy Owl Inn" at Waterville Valley for November 15-17. We will be surveying the membership to determine if we can get the 25 couples needed to sponsor it. The Professional Development Committee has proposed a subject for the morning seminar on Saturday with the monthly NHAFC meeting being held at 1:00 that afternoon. Hoping we can get the numbers and bring back this popular event.

1st Vice President Report (Watkins) – no report

Government Relations – (Schmidt) – (submitted in writing)

- **Ambulance Billing Issues** There are several bills dealing with ambulance reimbursement. Here is a breakdown of where each stand in the session:
 - o **SB 409 (Medicaid Re-imbursement for Treat/No Transport) -** the bill would require NH DHHS to file a Medicaid plan amendment which, under specific circumstances, would allow for re-imbursement for instances where an individual was treated, but not transported, to a hospital. Chief Mike Sitar attended the hearing and testified in favor. The bill passed the Senate Health and Human Services Committee. It was then referred to the Senate Finance Committee where it received a 7-0 vote in favor. It will head to the Senate Floor next week.

- HB 1568 (Medicaid Re-imbursement for Treat/No Transport) –
 This bill would also require the state Medicaid program to reimburse for non-transport emergency medical service calls. The bill has been heard by the House Health and Human Services Committee. A Committee vote is scheduled for March 20.
- HB 1081 (Direct Pay) HB 1081 was heard by House Commerce and a subcommittee voted 5-0 to pass the bill. The bill would require carriers to pay providers directly. The entire Committee will vote on the bill this week and it should go to the House floor later this month.
- o **SB 407 (Direct Pay/Local Rate Approval)** The bill was heard by the Senate Health and Human Services Committee. Chief Hunter testified in favor of the bill. The Committee recently passed the bill with an amendment, by a vote of 5-o. The amendment would do two things; require direct payment by carriers to providers and, in the absence of a contract, the carrier shall "...pay for such services at the rates set by local government or contract entity subject to a public process prior to adoption or readoption..." The Senate will vote on the bill and amendment later this month. It is not yet clear if it will be referred to Senate Finance for their review, should the amendment and bill pass.
- **HB 1647 (Group II Retirement Reforms)** The bill is a result of the Retirement Benefits Commission which met last summer and fall. It would adjust the retirement annuity multipliers for members who started service before 7/1/11 that were not vested by 1/1/12, and those who were hired after 7/1/11, to 2.5% per year for service in excess of 10 years. The bill appropriates almost \$56 million to cover the majority of the costs with this change. NHAFC will be submitted testimony in support of the bill. The House passed the bill in late February. It was referred to the House Finance Committee. A subcommittee will be reviewing the legislation this week. A full vote of the House Finance Committee should happen before the end of March. The bill will go back to the House Floor once House Finance finishes its work.
- SB 352 (Retired and Full Time Firefighter Cancer Screening Program)

 The bill would create a \$5 million fund from which re-imbursements to retired and full-time fight fighters could seek re-imbursement, up to \$1,300, when specific documentation is provided. NHAFC, PPFNH, and Fire Standards and Training would be responsible for development of an initial plan to implement the screenings. The plan would be submitted to the Governor and Commissioner of the Department of Safety. NHAFC signed in as supporting the legislation. The bill passed the Senate Health and Human Services Committee, the Senate Finance Committee, and finally the entire Senate on a 24-0 vote in late February. It has been referred to the House Health and Human Service Committee.
- **HB 1352 (PFAS in station wear/PPE)** As introduced, the bill would require Fire Departments to "...give preference" to PPE which does not include PFAS, once those alternatives are made available. In the interim, Fire Departments shall have in place a policy that limits unnecessary exposure to PPE.

Language is included that states it would remain a best practice from PPE to be used while operating in a dangerous environment. Regarding station wear, by January 1, 2025, Fire Departments shall not provide as an option any station wear that contains intentionally added PFAS or fire resistive chemicals (fluorine, chlorine, bromine, lead, or antimony). Manufacturers are required to provide safer alternatives, should they exist. The bill was requested by PFFNH. A subcommittee recently passed an amendment which would enable, but not mandate local fire departments to give preference to PPE which does not include PFAS. The amendment is consistent with prior conversations with PFFNH to ensure the bill could be enacted without confusion. The full House Executive Departments and Administration Committee should vote on the amendment and the bill soon.

• **Special Committee on Housing** – In 2023, the House created a committee to examine barriers to the creation of additional housing units. As housing became a critical issue for the state, the Committee spent a year receiving testimony from developers, regulators, municipal officials, and many other interested stakeholders.

The Committee held hearings on 7 bills that were developed by the special committee. **HB 1065** is intended to expand the existing sprinkler prohibition to include existing residential buildings with no more than 4 units, so long as the building is in compliance with the state fire code (including but not limited to fire barriers, dedicated ingress/egress, and monitored fire alarm systems). Previously, the sponsor has highlighted the costs associated with sprinklers when converting an existing residential building into several smaller units, within the same building envelope. Fire Marshal Toomey has been attempting to work with the Committee to address the concepts in the bill via the code process. The bill will head to the House floor soon with a recommendation for passage. HB 1215 proposes that codes that were applicable at the time of plat approval, site plan approval, and building permit issuance would be the codes that the project would be required to meet. There appears to be consensus on the committee that the language, which would include the fire and building codes, is too expansive. There will likely be an attempt to narrow the bill and exclude the codes from the concept. The final amendments to some of the bills should be available later this week. Any of the bills that pass the House will have to be heard in the Senate.

Board of Fire Control:

The next Board of Fire Control meeting is scheduled for June 19, 2024.

Foam Take-back Program:

The contract for the foam take-back program was approved by the Governor & Executive Council at the end of June 2023. DES has updated that they are now working on some facility disposal items with the vendor and anticipate the program remaining in a delayed status until late spring.

Strategic Planning Initiative:

Our office has worked over the past few months to develop an updated strategic plan which will be part of an overall Department of Safety plan. The high-level goals for the office include accreditation, development of a statewide community risk reduction program, employee development, development of a statewide hazmat strategic plan, and facility/office space enhancement.

BUREAU OF INVESTIGATIONS:

In the month of February, we received 9 incident notifications resulting in 3 scene responses. The Bureau of Investigations currently has 17 open arson or suspected arson investigations.

New cases (synopsis of some of our cases are listed below):

• On February 20, investigators responded to Goffstown to investigate a garage fire. The cause is suspected to be accidental due to careless disposal of smoking materials.

Fatal Fire/CO Incidents:

- On February 3, a male died in a structure fire in Littleton as a result of a fire believed to have been caused by smoking while on oxygen.
- On February 20, a female died in a structure fire in Litchfield. This investigation is ongoing and the cause is undetermined at this time.

•

Court:

 In February, two Investigators testified in Coos County Superior Court in an arson trial for a 2022 fire in Berlin. The suspect, Messiah McMaster, was found guilty.

BUREAU OF OUTREACH & EDUCATION:

Hazardous Materials:

Hazardous Materials response, coordination and consultation is available through the on-call FMO supervisor.

Our Hazardous Materials Coordinators are available for PEAC Software training for fire departments. PEAC is used for documentation of Tier II facilities and chemical storage.

In the month of February, our Hazardous Materials Coordinators attended the Haz Mat Collaborative Meeting, the quarterly CAMEO training and an Introduction to ChemResponder training. They also provided PEAC training to the Seacoast Haz Mat Team, met with the Twin State Haz Mat Team Coordinator and attended the Twin State Mutual Aid meeting.

Also, in the month of February, we received 531 Tier II reports from NH facilities. We also responded to 53 questions from facilities regarding Tier II reporting.

Electric Vehicles and Lithium-Ion Batteries

We have held three meetings to discuss the challenges of electric vehicle fires and lithium-ion batteries. The meetings have included representatives from the State Fire Marshal's Office, Fire Academy, HSEM, State Police, DMV, DES, DOT, Tow Association, Auto Dealers Association, Clean Energy NH, NH Chiefs of Police and the NH Association of Fire Chiefs.

The International Code Council has established an ad-hoc group to evaluate building and fire code impacts from electric vehicles and lithium-ion batteries. The National Fire Protection Association Research Foundation is conducting a study. UL's Fire Safety Research Institute (FSRI) is also conducting a study. UL FSRI has additional information and resources for first responders here: Safeguard the future of Lithium-Ion Battery Devices with FSRI (batteryfiresafety.org).

Regional Outreach/Chief's Roundtables:

We continue to partner with the Commissioner's Office, other Department of Safety Leadership and the NHAFC to conduct regional outreach/Chief's Roundtables. The next meeting is scheduled at the Burton Fire & EMS Training Facility in Bethlehem on April 11th at 10 am.

Incident Reporting:

Your commitment to ensuring we have great data to accurately show the fire problem in NH is greatly appreciated! Please remember to report any EV or lithium-ion battery fires to us.

Members presented a fire safety story time for preschoolers at the Chester Library and provided a K-9 demonstration at the Nashua Library. 

Public Education:

Have you seen our Risk Reduction Quarterly Newsletter yet? The inaugural edition was recently released in February and is focused on fire prevention topics, training opportunities and seasonal fire safety themes to support your work in your communities. We hope you enjoy it, and we hope you share it widely!

Are you familiar with the USFA's Fire and Life Safety Communicators Initiative? This initiative is a collaboration among the fire and emergency medical services to speak with "one voice" on fire and life safety. They believe in working together to present consistent messages. The theme for the month of March is smoke alarms. Make sure you have working smoke alarms inside and outside each sleeping area, on every level of the home. Test them at least 2 times a year and replace them according to the manufacturer's instructions. When choosing a smoke alarm, ensure it is certified by a national testing lab. Never disable your smoke alarms. If you can, make sure your smoke alarms are interconnected and speaking to each other. If one sounds, they all sound.

2023 Fatal Fire Statistics:

In 2023, there were 10 total fatal fires and eleven victims. Two thirds of victims were male (64%). Most fatal fires started at night or in the early hours of the morning, and half occurred on a Thursday or Friday. Nearly three quarters occurred from January to April (70%) and a third started in the kitchen (37%). Working smoke alarms could only be verified in 3 of the 8 fatal home fires, and 3 of the 8 victims attempted to fight the fire. Nearly three quarters of victims were 65+.

In comparison to 2022, several similarities were noted. In both years, a third of fatal fires occurred on Thursday. A majority of victims were over the age of 65. Most fatal fires took place after 6:00PM and before 7:00AM. More than two thirds of the time, working smoke alarms were missing or couldn't be verified.



<u>Personnel</u>

- Two conditional offers have been made for the upcoming vacancies due to retirement for full-time EMS Captain's.
- ➤ The open Fire Service Instructor Supervisor position in the Bureau of Certification and Support remains open.
- ➤ We have one vacancy for Program Specialist III (Education Technologist) of the Educational Technology section.
- A candidate has been selected for the Program Assistant I position who will begin with us in March.
- ➤ We continue to advertise for our three new full-time Fire Training Instructors. One conditional offer has been made to a candidate. Additional applications are under evaluation and we expected to begin the next phase of the process in March.
- A conditional offer has been made for our part-time Compliance Specialist position.
- ➤ A conditional offer has been made for our part-time EMS Vehicle Inspector Coordinator position.
- ➤ Our part-time Program Coordinator position for Fire Officer is open and we are seeking applicants.
- ➤ Our part-time Program Coordinator position for CPAT is open and we are seeking candidates.

Grants

- ➤ We have submitted an application for the 2023 AFG program for over \$500k for new and updated equipment to support training programs.
- ➤ The Raymond S. Burton Fire and EMS Training Facility infrastructure project continues to move forward. The contract with the selected vendor is being completed with construction on phase I expected this Spring/Summer.
 - In February the Governor and Executive Council approved additional funding (\$3.2m) needed to complete phase II of this project.
- ➤ The Department of Health and Human Services Covid Disparities Funding program funds (over \$400K) from will allow us to expand Image Trend to add Continuum, additional IFT, MIH and simulation training and staff support.
 - The Governor and Executive Council approved this in February.
- ➤ The NH EMT Training Program remains active with grant funding for training new and existing EMS providers. Contact our Division or NH Employment Security for details and question.
- The Law Enforcement Officers, Professional Firefighters and Emergency Medical Technicians Career Development, Recruitment and Retention Program committee established in New

Hampshire RSA 188-F:70 announced the new program on December 18th. Details can be found on our website under the Recruitment and Retention link from the homepage.

Special Projects

- We are near completion on the Division strategic plan for FY 25-27.
- ➤ We are working on our website transition and improvements with NH DoIT. A staff lead has been identified and has begun work on this transition.
- ➤ Wi-Fi improvements to better support students and guests at our Concord campus in the Administration building, Dormitory, Fire Station and ARFF classroom have been completed.
- ➤ We are partnering with the International Society of Fire Instructors to bring their *Water Mapping* program to the Fire Academy. Part of this project will be constructing the prop, offering a trainthe-trainer program and then a student offering of the class this July.
- ➤ We are working with our DOS partners to acquire fifty portable radios to be used in our programs. They will also be updating the frequencies in existing radios.

Facilities

- We are working to have an inspection done of the "A" building.
- ➤ We have begun updates to the entrance and main floor area of the Richard Flynn Fire Academy building.

Legislative/Administrative Rules

- ➤ The Fire Standards and Training Commission amended Fire rules relative to the Recruitment and Retention report and its recommendations are working through the internal legal process in preparation for submission to the Joint Legislative Committee on Administrative Rules (JLCAR) which will include public input.
- ➤ The Educational Training Agency ruleset (Saf-C 5900 EMS) continues to be facilitated through the JLCAR process.
- The proposed Trauma Rules are working through the internal legal process.
