#### **ADMINISTRATION:**

#### Legislation:

The process of submitting legislative service requests (LSR's) begins in the House & Senate begins this month.

We will work to evaluate the LSR's and share information as it becomes available.

- SB 170 relative to small group child day care centers Status: Signed by the Governor

#### **Board of Fire Control:**

The Board of Fire Control and the SFMO staff have reviewed the 2021 editions of NFPA 1 and NFPA 101. The goal is to have a package ready for legislative action in 2024. A public hearing will be held on September 20<sup>th</sup> to address amendments.

  - Maintain current sprinkler protection requirements for new restaurants and bars
  - Maintain current sprinkler protection requirements for new daycare facilities

- Amend NFPA 1 to allow portable generators to be spaced at 5' (current requirement) instead of 20' as proposed

#### Foam Take-back Program:

The contract for the foam take-back program was approved by the Governor & Executive Council at the end of June. DES has advised the project has been delayed to later this fall due to trucking issues with the subcontractor.

#### Residential Sprinklers in 3 & 4 family dwellings:

We continue to get inquiries on the need for residential sprinklers in 3 & 4 family dwellings due to the impacts of cost associated with the affordable housing crisis.

We brought together a stakeholder group meeting that included fire service representation from the Board of Fire Control, NH Association of Fire Chiefs and NH Fire Prevention Society. At this time, we anticipate a bill being sponsored again this session. A few other states have developed code amendments for existing buildings undergoing renovation that are less restrictive than the provisions for new apartments. The group will assess the options in the interest in balancing the code requirements, life safety and costs. A follow-up meeting will be held on September 18<sup>th</sup>.

#### **BUREAU OF INVESTIGATIONS:**

In the month of August, we received 9 incident notifications resulting in 3 scene responses. The Bureau of Investigations currently has 23 open arson or suspected arson investigations.

#### New cases (synopsis of some of our cases are listed below):

• On August 2, an investigator responded to Pelham to assist the Pelham FD with documenting a carbon monoxide exposure incident that left four people

with CO symptoms at a workplace. All four people have made a recovery.

- On August 5, investigators responded to Claremont to assist with an origin and cause investigation at a large commercial building. There were criminal indicators, and the investigation is ongoing.
- On August 31, investigators responded to Alstead to investigate a structure fire that started in an attached barn. The cause is under investigation.

#### Ignitable Liquid Detection Canine Teams:

• IGL canine teams performed 8 demonstrations in Concord, Pembroke, Somersworth, Bristol, Salem and Hooksett.

#### Youth Firesetter:

• There was one youth fire setter assessment and one inquiry in August.

#### Court:

• FMO personnel were prepared to testify in two court hearings in August, one of which was dismissed and the other in which the suspect failed to appear. A warrant was issued for that person's arrest for failing to appear in court.

FMO investigators are available to assist agencies day or night with investigations involving fire, carbon monoxide releases and building collapse. Depending on the type of investigation, it may be as simple as contacting the on-call supervisor and providing a consult over the phone. In other instances, it may be necessary to send out a team of investigators to assist with the origin and cause investigation. Please do not hesitate to reach out to our office for assistance. **Fire Investigations** (NH RSA 154:7-a) states, "The fire officer in charge or designee shall investigate the cause and origin of fires, including the taking of evidence relative to the cause and origin of fires...."

**Report of Causes and Origins of All Fires** (NH RSA 153:11) states, "When the cause, origin and circumstances of any fire occurring in any city, town, village, district or precinct in this state indicates that such fire was the result of design, or of suspicious origin, the fire chief shall immediately notify the state fire marshal."

**Investigations** (NH RSA 153:18) states, "Any fire, building collapse, or release of carbon monoxide other than from a motor vehicle occurring where death results shall be reported immediately to the office of the state fire marshal by the fire chief, and the office of the state fire marshal shall investigate the fire, building collapse, or release of carbon monoxide within 48 hours after receiving said report."

#### **BUREAU OF BUILDING SAFETY & CONSTRUCTION:**

#### State Building Permit System:

We processed the following permits in the month of August:

#### Technical Assistance, Educational & Healthcare Reviews:

We initiated 10 educational and 6 healthcare plan reviews, completed 263 inspections and 166 technical consults in the month of August.

Since July 1<sup>st</sup>, the State Fire Marshal's Office is responsible for the review of all licensed healthcare facility plan reviews for new construction and renovations pursuant to RSA 151:6. The office will complete plan reviews and final inspections for state building and fire code compliance and make recommendations for approval to the Department of Health and Human Services for clinical licensure.

#### Variance Requests:

We processed 7 variance requests in the month of August.

#### **BUREAU OF OUTREACH & EDUCATION:**

#### <u>Hazardous Materials:</u>

Hazardous Materials response, coordination and consultation is available through the oncall FMO supervisor.

Our Hazardous Materials Coordinator is available for PEAC Software training for fire departments. PEAC is used for documentation of Tier II facilities and chemical storage.

In the month of August, our Hazardous Materials Coordinator provided PEAC software training to the Southeast Haz Mat Team, attended the Haz Mat Collaborative Meeting and attended the quarterly meeting of the CAMEO software working group. He has also been working with HSEM regarding the 2024 HMEP Grant applications.

#### **Electric Vehicles and Lithium-Ion Batteries**

On June 13<sup>th</sup> an initial meeting to discuss the challenges of electric vehicle fires was held at the IPOC. An initial group to include the State Fire Marshal's Office, Fire Academy, HSEM, State Police, DMV, DES, DOT, Tow Association, Auto Dealers Association, NH Chiefs of Police and the NH Association of Fire Chiefs has been identified to collaborate on this topic. The intent is to share resources and identify training and code impacts relative to EV's and lithium-ion batteries. A follow-up meeting is scheduled on September 19<sup>th</sup>.

#### Regional Outreach/Chief's Roundtables:

We continue to partner with the Commissioner's Office, other Department of Safety Leadership and the NHAFC to conduct regional outreach/Chief's Roundtables. The next scheduled meeting is September 13<sup>th</sup> at the Souhegan Mutual Aid meeting in Mont Vernon.

#### Incident Reporting:

If you don't already have an account to securely transfer to and receive files from the SFMO, please register for free today!

The deadline to submit 2022 NFIRS data was July 1<sup>st</sup>. If you still have 2022 data to submit, we ask that you do so as soon as possible so we can close out the year in a timely fashion. Your commitment to submitting ASAP is greatly appreciated!

Have you looked at your .err files lately? These are important files that you likely receive on a monthly basis that contain invalid incidents, a.k.a. error messages. We can help you through the process so that you can resubmit any invalid incidents and receive full credit. Please contact us at <u>nhfirs@dos.nh.gov</u>.

We continue to work with the team at the Fire Academy as departments implement the NHESR program, available free of charge, for incident reporting. If you are interested in having a presentation on the program or would like to request one, please email <u>NHESR@dos.nh.gov</u>.

In May, the U.S. Fire Administration (USFA) announced their effort to launch a new fire information and analytics platform, known as the National Emergency Response Information System (NERIS), for the American fire and emergency services. Once NERIS is developed and operational, USFA will work to migrate fire and emergency services departments onto the new platform. The legacy NFIRS will remain operational throughout the transition process so all fire and emergency services departments should continue to use the current NFIRS data system and maintain status quo until migrated to the new platform. ## <u>Grants</u>

➢ We continue to acquire equipment funded by the \$476,186, 2022 AFG that we were awarded.

- The architectural firm retained for the Raymond S. Burton Fire and EMS Training Facility project is proceeding with obtaining necessary permits and completion of the construction documents in preparation of advertising the project for bids this fall.
  - Land clearing is expected to begin this fall/winter with site work starting in the spring of 2024.
- ➢ We continue to work with the Department of Health and Human Services Covid Disparities Funding program to expand Image Trend to add Continuum, additional IFT, MIH and simulation training and staff support.
- > The NH EMT Training Program remains active with grant funding for training new and existing EMS providers. Contact our Division or NH Employment Security for details and question.

## Special Projects

- We are in the process of standardizing training program delivery documents including course syllabus and schedules.
- We plan to announce the release of our new Moodle platform this month which includes many improvements.

- We are working on a project to support the modular delivery of Firefighter I and Firefighter II as allowed in the Fire Administrative rules. Students will be able to directly self-enroll into any of the online Firefighter I and II modules and achieve completion. A State instructor will then be able to conduct the practical skills training and submit the course completion paperwork for students to achieve completion of a module. After a student completes all modules they would be eligible for certification testing.
- > We have begun the planning process for our website transition and improvements with NH DoIT.
- The New Hampshire Fire and EMS Committee of Merit and the annual awards ceremony will be held on Sunday, September 17<sup>th</sup> at the Capital Center for the Arts at 1330.
- > The annual FF Memorial will be held on Saturday, September 23<sup>rd</sup> at 1000.
- The Law Enforcement Officers, Professional Firefighters and Emergency Medical Technicians Career Development, Recruitment and Retention Program committee established in New Hampshire RSA 188-F:70 met on September 7<sup>th</sup>. The next meeting will be held October 12<sup>th</sup> at the Fire Academy, 1100 in the Dorm building, Classroom 7.

## <u>Facilities</u>

We are working on the replacement of two AC condenser units in the older portion of the dormitory building. The bid process, issuing of contracts and Governor and Council approval are anticipated this fall.

## Legislative/Administrative Rules

- > The Fire Standards and Training Commission amended Fire rules relative to the Recruitment and Retention report and its recommendations are working through the internal legal process in preparation for submission to the Joint Legislative Committee on Administrative Rules (JLCAR) which will include public input.
- > The Educational Training Agency ruleset (Saf-C 5900 EMS) continues to be facilitated through the JLCAR process.
- The House LSR filing period is from September 11<sup>th</sup>-15<sup>th</sup> and the Senate filing period opens on September 28<sup>th</sup>.

## <u>Outreach</u>
