Report of the Executive Director: (Lemire)

• Chiefs Best, Hunter, Watkins, Lemire and Carrier attended the North Country Public Safety Awards dinner on November 10.

- Starting to work on pricing out the CFSI event to determine attendees. (Possibly 6)
- The January association meeting will be virtual.
- February meeting will be a breakfast meeting at the Academy with a Professional Development opportunity focused on municipal cybersecurity, sponsored by HSEM and Primex.
- March meeting....discussion.
- Exploring a venue for the April Annual Meeting. Manchester site unavailable. Looking at the Common Man in Plymouth again, Chief Morrison is checking on space as we'd like to have the Vendor Showcase there also.
- At the BOD meeting, discussion ensued as to the types of meetings to be held. It was decided to have one virtual meeting, one breakfast meeting and one luncheon or dinner meeting per quarter.
- It was also decided to virtually engage the professional development committee asap to discuss opportunities for programs each quarter.
- ED Lemire also mentioned that he has contacted Director Cutting to see if we could be notified when a new chief comes on board in a municipality. Chief Jones asked if they could receive the same information. Director Cutting has agreed to assist in this endeavor.
- Deputy Chief Craig Clough of Loudon has offered to serve as our representative for the Trauma Medical Review Board, and has been appointed by the Commissioner.
- Chief Thomas Blanchette has been nominated by the BOD to serve on the Manufactured Standards Housing Board and has been nominated by the Governor. Final vote is next Wednesday.

1st Vice President Report (Watkins) - No report

Government Relations – (Schmidt) – (submitted in writing)

- **2024 Bill Titles** The filing period for 2024 legislation has passed for both the House and Senate. Bills continue to be printed and about half of them have been made public so far. We have included a chart which contains all of the bills we have identified for NHAFC to date. The bill number provides a link to the text. Any of the titles which start with "LSR" are still not public. All that is available is the bill title, at this point. Those titles do not have a corresponding link to the language. We should see all of the bills within the next few weeks. Hearings on the new bills should start in January.
- Ambulance Summit The discussions regarding ambulance are schedule to wrap up next week when the final working group meeting has been scheduled. At a meeting on Wednesday at the Department of Insurance, there appeared to be recognition from NH DOI staff that consensus on a potential fee schedule or payment structure has not yet been achieved. The final meeting has been scheduled for next week. It is not yet clear what type of legislation, if any, will

come out as a result of the working group. Chief Scott Hunter and Chief Mike Sitar have been very involved in the process and can answer questions or provide additional insight. *Chief Hunter added background information and clarified the issue for the members.*

- **Retirement Benefits Commission** During the debate on the state budget, language was removed, which would have eliminated the "middle tier" in Group II. The language to eliminate the middle tier was replaced a Study Commission consisting of legislators and participants (employer/employee) in the retirement system. Last month, in a very close vote, the Commission voted to support legislation which would make all members of the mid-tier, those hired after the 2012 changes, and all new hires to receive a 2.5% multiplier for any years worked beyond 10. The cost to make this plan "pre-funded" was around \$56 million. There was an alternative plan which would have created the same benefit, for the same group, after 15 years. The cost to pre-fund this benefit was around \$36 million. There appears to be consensus regarding the concept of restoring the 2.5% after a certain amount of years worked, but there was disagreement about the term (10 vs. 15 years), which impacted the cost. There should be a bill in to make this change for 2024. There are several additional retirement systems bills included on the chart as well.
- **Housing Legislation** Housing has become a higher profile issue over the past several sessions. This past year, the House created a "Special Committee on Housing". They spent about a year hearing from different interested parties regarding housing policy (Municipal land use regulators, Fire Marshal, developers, housing advocates, etc.) You will note a number of bills aimed at helping address the issues surrounding housing supply. Some deal with codes, other at expanding the sprinkler prohibition to include retrofitted, existing structures to include up to 4 units, and allowing for multiple ADUs on a single property.
- Lithium Batteries NHAFC has been asked to support HB 1386 sponsored by Rep. Karen Ebel. The bill is intended to prohibit disposal of lithium batteries in local transfer stations, landfills and composting facilities. Rep. Ebel is concerned with the potential impacts of fires as well as environmental damage. A copy of the bill can be accessed via the chart. There are a number of other bills attempting to develop some regulations based on the potential hazards associated with EVs, charging stations, etc.

HB 1215 Relative to subdivision regulations on the completion of improvements and the regulation of

building permits

HB 1332 Relative to prohibiting electric vehicles from parking in parking garages

- HB 1352 Relative to firefighting personal protective equipment
- HB 1386 Relative to prohibiting the disposal of lithium-ion batteries in solid waste landfill facilities, composting facilities, or incinerators.
- HB 1387 Relative to revisions to the state building code
- HB 1396 Relative to prohibiting municipal inspections of owner-occupied units of multi-unit housing
- HB 1498 Establishing a state short term rental registry
- HB 1510 Establishing a commission to identify barriers to and solutions for electric vehicle sales and use.
- SB 430 relative to establishing a commission to study the impacts of electric vehicles, lithium-ion batteries, and e-mobility devices on first responder response, the environment, building and fire codes, and life and safety property protection.
- SB 437 Relative to local authority to amend the state building code.

There are still several LSR's that we are watching for language on and several bills that we will be updating on once we have more information.

Board of Fire Control:

The next Board of Fire Control meeting is scheduled for January 17, 2024. Everything is submitted to the legislature to update the State Fire Code to the 2021 editions of NFPA 1 & 101.

Foam Take-back Program:

The contract for the foam take-back program was approved by the Governor & Executive Council at the end of June. DES has advised the project has been delayed due to trucking issues with the subcontractor. Additional information will be released as soon as we have them.

Strategic Planning Initiative:

Our office is working over the next several months to develop an updated strategic plan which will be part of an overall Department of Safety plan.

BUREAU OF INVESTIGATIONS:

In the month of November, we received 20 incident notifications resulting in 8 scene responses. The Bureau of Investigations currently has 20 open arson or suspected arson investigations.

New cases (synopsis of some of our cases are listed below):

- On November 1, investigators responded to a motor-vehicle crash and fire in Derry that had resulted in a fatality later determined to be a trauma death, not a fire death.
- On November 4, investigators responded to a fireworks-related fire in Allenstown.
- On November 8, investigators and an IGL canine team responded to a structure fire in Fitzwilliam that was probably caused by an electrical issue.
- On November 13, investigators responded to Loudon to investigate a fire in a structure related to a barricaded subject incident. The cause of the fire is under investigation.
- On November 16, investigators responded to Merrimack to assist with the investigation of a fire in a storage container being used as a residence that

resulted in burn injuries to the occupant. A space heater is suspected to have ignited bedding.

- On November 19, investigators responded to a burn injury in Rochester resulting from an accidental cooking fire.
- On November 20, investigators and an IGL canine team responded to a structure fire in Franklin that coincided with a barricaded subject and officer-involved shooting that resulted in the occupant's death. The cause of the fire is under investigation.
- On November 28, investigators assisted NH State Police with a homicide investigation in Goffstown. The cause of the fire is under investigation.

Youth Firesetter:

• There were no youth fire setter assessments and 3 inquiries in November.

Court:

• FMO personnel presented a case to a Merrimack County Grand Jury for a Possession of Infernal Machine charge that occurred in Allenstown in 2021. Personnel also attended a sentencing hearing in Grafton County where the defendant failed to appear again, and a warrant was issued for his arrest.

Training/Committees:

- The BOI Bureau Commander attended an internal affairs training class at the Federal Law Enforcement Training Center in Glynco, Georgia in November.
- Several members of the FMO attended law-enforcement accreditation training in November. This will be an ongoing practice in advance of obtaining national accreditation.

BUREAU OF BUILDING SAFETY & CONSTRUCTION:

<u>State Building Permit System:</u>

We processed the following permits in the month of November:

Technical Assistance, Educational & Healthcare Reviews:

We initiated 13 educational and 7 healthcare plan reviews, completed 241 inspections and 145 technical consults in the month of November.

Variance Requests:

We processed 11 variance requests in the month of November.

<u>Modular Building Program</u>

We completed 5 modular building inspections in the month of November.

BUREAU OF OUTREACH & EDUCATION:

Hazardous Materials:

In the month of November, we welcomed our new, full-time Hazardous Materials Coordinator Michael Barry. He is looking forward to getting out and meeting department and Haz Mat team members.

Hazardous Materials response, coordination and consultation is available through the on-call FMO supervisor.

We are available for PEAC Software training for fire departments. PEAC is used for documentation of Tier II facilities and chemical storage.

In the month of November, we provided training on the Suspicious Package Protocol to the Southeastern NH Haz Mat Team and provided technical assistance to the Franklin Fire Department during a gasoline incident. We also attended the Haz Mat Collaborative Meeting, the monthly PEAC Software Training and attended a planning meeting for the NH Haz Mat Conference. We continue to work with HSEM on the HMEP Grant applications.

Electric Vehicles and Lithium-Ion Batteries

We have held several meetings to discuss the challenges of electric vehicle fires and lithium-ion batteries. The meetings have included representatives from the State Fire Marshal's Office, Fire Academy, HSEM, State Police, DMV, DES, DOT, Tow Association, Auto Dealers Association, Clean Energy NH, NH Chiefs of Police and the NH Association of Fire Chiefs. The next meeting is scheduled on January 16, 2024. The International Code Council has established an ad-hoc group to evaluate building and fire code impacts from electric vehicles and lithium-ion batteries. The National Fire Protection Association Research Foundation is conducting a study. UL's Fire Safety Research Institute is also conducting a study. UL FSRI launched a lithium-ion battery educational outreach initiative in mid-November.

Incident Reporting:

End of year is here! We ask that you please submit your 2023 data as soon as possible. Your commitment to ensuring we have great data to accurately show the fire problem in NH is greatly appreciated! If you are having difficulty sending your data or need assistance, please reach out to our team.

Did you know that we are transitioning away from accepting data via email attachments? If you are a department that submits via email attachment and have not yet created a Secure File Transfer Protocol (SFTP) Account, please reach out to our team for assistance. Our goal is to have all departments submitting data via the SFTP on or before January 1, 2024.

Have you looked at your .err files lately? These are important files that you likely receive on a monthly basis that contain invalid incidents, a.k.a. error messages. We can help you through the process so that you can resubmit any invalid incidents and receive full credit. Please contact us at nhfirs@dos.nh.gov.

We continue to work with the team at the Fire Academy as departments implement the NHESR program, available free of charge, for incident reporting. If you are interested in having a presentation on the program or would like to request one, please email <u>NHESR@dos.nh.gov</u>.

We released the latest edition of our NHFIRS Quarterly Newsletter and our brand new NHFIRS Incident Coding Guide, a resource we think will help those responsible for incident reporting – both new and veteran reporters! The guide covers topics such as:

- How to calculate property loss
- Plus-one codes
- Incident type scenarios
- Impact reporting has on communities local, state and national

In May, the U.S. Fire Administration (USFA) announced their effort to launch a new fire information and analytics platform, known as the National Emergency Response Information System (NERIS), for the American fire and emergency services. Once NERIS is developed and operational, USFA will work to migrate fire and emergency services departments onto the new platform. The legacy NFIRS will remain operational throughout the transition process so all fire and emergency services departments should continue to use the current NFIRS data system and maintain status quo until migrated to the new platform. ADMINISTRATION

<u>Personnel</u>

- The open Fire Service Instructor Supervisor position in the Bureau of Certification and Support remains open. We have updated the job description and are waiting for approval from the Division of Personnel and then the position will be re-advertised.
- We have one vacancy for Program Specialist III (Education Technologist) of the Educational Technology section of the Division and we have advertised the positions for candidates.
- > We continue to advertise for our three new full-time Fire Training Instructors.
- We have one part-time Compliance Specialist position open and interviews will begin this month.

- The part-time EMS Vehicle Inspector Coordinator position application period has closed and we are conducting interviews.
- Our part-time Program Coordinator position for Fire Officer is open and we are seeking applicants.
- Karen Scott has been hired as the Program Coordinator for EMS Initial Programs and will begin in that role at the end of December.
- > Bob Field has been hired as the Program Coordinator for the Instructor Programs.

<u>Grants</u>

- The architectural firm retained for the Raymond S. Burton Fire and EMS Training Facility project has finalized the construction documents.
 - Advertisement of bids is planned for December 12th.
 - Land clearing is expected to begin this fall/winter with site work starting in the spring of 2024.
- The Department of Health and Human Services Covid Disparities Funding program we are seeking funds from will allow us to expand Image Trend to add Continuum, additional IFT, MIH and simulation training and staff support. We are working this through Governor and Executive Council for their approval.
- The NH EMT Training Program remains active with grant funding for training new and existing EMS providers. Contact our Division or NH Employment Security for details and question.

Special Projects

- > We have begun the planning process for our website transition and improvements with NH DoIT.
- We have coordinated with DoIT on an assessment of our classroom technology and are awaiting the recommendation report.
 - We are working on WiFi improvements to better support students and guests at our Concord campus in the Administration building, Dormitory, Fire Station and ARFF classroom. These upgrades are planned to be completed in January.
- The Law Enforcement Officers, Professional Firefighters and Emergency Medical Technicians Career Development, Recruitment and Retention Program committee established in New Hampshire RSA 188-F:70 met on December 12 to finalize the plan criteria and procedures. The program will be announced December 18th.
- The Education Technology section is working to update the online Narcan for First Responders course, the Hazardous Materials course and many Firefighter I and II modules.

Facilities

The replacement of two AC condenser units in the older portion of the dormitory building will be completed this winter after receiving final approval this month.

Legislative/Administrative Rules

- The Fire Standards and Training Commission amended Fire rules relative to the Recruitment and Retention report and its recommendations are working through the internal legal process in preparation for submission to the Joint Legislative Committee on Administrative Rules (JLCAR) which will include public input.
- We have opened the sixty (60) day public comment period on the proposed State of New Hampshire Patient Care Protocols Version 8.2, specifically the Operational K9 Prerequisite Protocol.
