- Request from Chief Thomas to act on a MOTION "Move that the New Hampshire Association of Fire Chiefs accept the Terms of the Hazardous Materials Emergency Preparedness (HMEP) Grant as presented in the amount of \$23500.00 for Hazmat Training. The NHAFC acknowledges the total cost of \$29375.00 in which the NHAFC is responsible for \$5875.00 a 20% match. Also to authorize President David Emanuel, Treasurer Stephen Carrier,

and BOD Member Henry Thomas Jr to sign all documents concerning the Grant." (Thomas/Hunter). Motion carried unanimously.

- Chief Thomas also spoke on the 2024 HazMat conference is on April 17 and 18, 2024, He also shared the subjects of the conference and the parts of the agenda that's finalized. He asked Shawn about setting up a sign-up system in our program.
