President's Report: (Emanuel) -

<u>CFSI 2024:</u> On April 29-30, 2024, the Congressional Fire Services Institute (CFSI) will host the 34th Annual National Fire and Emergency Services Symposium and Dinner in Washington, DC. Members of the Board will be attending. Recruitment & Retention:

• EO/PFF Career Development - education funding group met on December 12th with a plan to open funding applications in January for the NH Community College System tuition and fee reimbursement program for first responders.

Program posting:

• Law enforcement officers and current full-time, career, part-time, on-call or volunteer firefighters and emergency medical technicians qualify for reimbursements through the program. The program covers tuition and fees for one course per semester and is subject to eligibility, available funding and successful completion with a grade of C or better. Participating employees will be certified as eligible by their employers.

<u>Lithium Ion Battery/EV State Workgroup:</u>

• The group cancelled the December meeting because there had not been any new information or recommendations presented. There is pending legislation to establish a State level commission to work on this project.

Report of the Executive Director: (Lemire)

- The February 8 breakfast meeting will be at the NHFA in Concord with a special seminar on cybersecurity. We will dine in the cafeteria then move to the auditorium for the seminar and meeting.
- The CFSI event this year has been rescheduled to April 29-May 1. Your Officers will represent the Association this year at the event.
- March 14 meeting after discussion, it was suggested that we try Alan's of Boscawen again for a Corned Beef and Cabbage dinner/meeting.
- We have booked space for the April Annual Meeting. The Common Man in Plymouth is able to offer the space needed for the seminar, vendor showcase, meeting and dinner on April 11.
- For May, we will partner again with Primex for our meeting during their annual conference in Portsmouth May 15 16. Our meeting would be the Thursday the 16th.

Director Cutting gave a report from the Professional Development Committee. He was elected Chair. The initial steps they decided on were to survey the membership on their needs first. They will get that to me soon for dissemination. They will meet remotely on Thursday's at 12:30, dates to be set still.

1st Vice President Report (Watkins) –

Government Relations – (Schmidt) – (submitted in writing)

• 2024 Session – The House and Senate started the public hearings on bills last week. They have a few weeks to hear any bills that spend or raise money before they must go to the floor. It will be very busy in Concord for the next several weeks. Included with the update is a legislative chart. As a reminder, the bill number provides a link to the text. If there are bills on which you have questions that are not included as part of the following update, please let us know.

- SB 409 (Medicaid Re-imbursement for Treat/No Transport) The bill would require NH DHHS to file a Medicaid plan amendment which, under specific circumstances, would allow for re-imbursement for instances where an individual was treated, but not transported, to a hospital. Chief Mike Sitar attended the hearing and testified in favor. The Committee may amend the bill to address some technical concerns. There was no opposition at the hearing.
- HB 1647 (Group II Retirement Reforms) The bill is a result of the Retirement Benefits Commission which met last summer and fall. It would adjust the retirement annuity multipliers for members who started service before 7/1/11 that were not vested by 1/1/12, and those who were hired after 7/1/11, to 2.5% per year for service in excess of 10 years. The bill appropriates almost \$56 million to cover the majority of the costs with this change. There hearing on the bill is scheduled for Thursday, January 11. NHAFC will be submitting testimony in support of the bill.
- SB 352 (Retired and Full Time Firefighter Cancer Screening Program) The bill would create a \$5 million fund from which re-imbursements to retired and full time fight fighters could seek re-imbursement, up to \$1,300, when specific documentation is provided. NHAFC, PPFNH, and Fire Standards and Training would be responsible for development of an initial plan to implement the screenings. The plan would be submitted to the Governor and Commissioner of the Department of Safety. The bill includes reporting requirements to the Legislature. The hearing on the bill has not yet been scheduled.
- HB 1081 (Direct Re-imbursement from private health carriers for ambulance services). This bill would require direct payment to ambulance service providers by removing the section of law that enables carriers to send payment to their member. The hearing on this bill has been scheduled for January 18 at 2:15 pm.

HB 1352 (PFAS in station wear/PPE) – The bill would require Fire Departments to "...give preference" to PPE which does not include PFAS, once those alternatives are made available. In the interim, Fire Departments shall have in place a policy that limits unnecessary exposure to PPE. Language is included that states it would remain a best practice from PPE to be used while operating in a dangerous environment. Regarding station wear, by January 1, 2025, Fire Departments shall not provide as an option any station wear that contains intentionally added PFAS or fire resistive chemicals (fluorine, chlorine, bromine, lead, or antimony). Manufacturers are required to provide the safer alternatives, should they exist. The bill was requested by PFFNH. NHAFC has had some initial conversations with them regarding potential challenges with implementation and potential costs for PPE. The hearing has not yet been scheduled.

Board of Fire Control:

The next Board of Fire Control meeting is scheduled for January 17, 2024. Everything is submitted to the legislature to update the State Fire Code to the 2021 editions of NFPA 1 & 101.

<u>Foam Take-back Program:</u>

The contract for the foam take-back program was approved by the Governor & Executive Council at the end of June 2023. DES has updated that they are now working on some facility disposal items with the vendor and anticipate the program remaining in a delayed status until late spring.

Strategic Planning Initiative:

Our office is finalizing an updated strategic plan which will be part of an overall Department of Safety plan. Please reach out with any thoughts.

BUREAU OF INVESTIGATIONS:

In the month of December, we received 20 incident notifications resulting in 9 scene responses. The Bureau of Investigations currently has 18 open arson or suspected arson investigations.

New cases (synopsis of some of our cases are listed below):

- On December 6, investigators responded to a double fatal in Claremont. The deaths were initially believed to have been due to CO poisoning, but the autopsies determined they were not caused by CO. The official cause and manner of death is pending.
- On December 8, investigators responded to Pittsfield for a consult for an accidental electrical fire.
- On December 9, an investigator responded to Warren for a fire investigation, with injury. The victim was transported to Boston for medical treatment. The fire cause is undetermined.
- On December 12, investigators responded to Gilmanton for a consult on an accidental electrical fire.
- On December 15, investigators responded to North Hampton for the passing of a Rye Fire Department Lieutenant, that had occurred within hours of completing a shift.

- On December 20, investigators responded to Colebrook for an accidental fire in a vacant cabin.
- On December 20, investigators responded to Bartlett for a fire in an 8unit condominium. The cause of the fire was likely an accidental electrical issue.
- On December 31, investigators responded to Campton for a RV fire. The cause of the fire was determined to be accidental.

Fatal Fire/CO Incidents:

On December 7, an investigator responded to Conway for a CO death investigation. The death was determined to be a suicide.

Arrests:

• There was 1 arrest by the FMO in December. The arrest stemmed from a joint investigation with the Bradford Police and Fire Departments. Nathan Nichols was arrested and charged with five counts of felony level arson which involved multiple outside fires, two of which involved structures. These fires occurred between May 2022 and September 2023 in the towns of Bradford and Warner. Nichols was released on personal recognizance bail and an arraignment is scheduled in February.

Training/Committees:

 Members of the FMO attended a three-day training presented by Dr. David Icove, a professor from the University of Tennessee, who specializes in fire investigations and fire protection engineering.

BUREAU OF BUILDING SAFETY & CONSTRUCTION:

State Building Permit System:

We processed the following permits in the month of December:

Technical Assistance, Educational & Healthcare Reviews:

We initiated 11 educational and 7 healthcare plan reviews, completed 179 inspections and 124 technical consults in the month of December.

Variance Requests:

We processed 11 variance requests in the month of December.

Modular Building Program

We completed 10 modular building inspections in the month of December.

BUREAU OF OUTREACH & EDUCATION:

Hazardous Materials:

Hazardous Materials response, coordination and consultation is available through the on-call FMO supervisor.

Our Hazardous Materials Coordinators are available for PEAC Software training for fire departments. PEAC is used for documentation of Tier II facilities and chemical storage.

In the month of December, our Hazardous Materials Coordinators attended the Haz Mat Collaborative Meeting, the monthly PEAC Software Training, the EPA Webinar on Ammonia Facility Operations and Safety, the DEA Clandestine Lab Training and the Radiation Response Training with the NH National Guard CST. In addition, they assisted the Seacoast Haz Mat Team with SHSP Grant applications.

Also, in the month of December, one of our Hazardous Materials Coordinators attended the Hazard 3 Lithium Battery Program at the Massachusetts Fire Academy. This program discussed dealing with Lithium-Ion Batteries during incident responses and establishing ideas on how to stabilize what is happening safely.

Electric Vehicles and Lithium-Ion Batteries

A stakeholder meeting to discuss the challenges of electric vehicle fires and lithium-ion batteries will be held on January 16th at the IPOC. These meetings have included representatives from the State Fire Marshal's Office, Fire Academy, HSEM, State Police, DMV, DES, DOT, Tow Association, Auto Dealers Association, Clean Energy NH, NH Chiefs of Police and the NH Association of Fire Chiefs.

<u>Regional Outreach/Chief's Roundtables:</u>

We continue to partner with the Commissioner's Office, other Department of Safety Leadership and the NHAFC to conduct regional outreach/Chief's Roundtables. Please reach out if you are interested in hosting a meeting.

Incident Reporting:

If you have not yet submitted your 2023 data, we ask that you please submit it as soon as possible. Your commitment to ensuring we have great data to accurately show the fire problem in NH is greatly appreciated! If you are having difficulty sending your data or need assistance, please reach out to our team.

Did you know that we are transitioning away from accepting data via email attachments? If you are a department that submits via email attachment and have not yet created a Secure File Transfer Protocol (SFTP) Account, please reach out to our team for assistance.

Have you looked at your .err files lately? These are important files that you likely receive on a monthly basis that contain invalid incidents, a.k.a. error messages. We can help you through the process so that you can resubmit any invalid incidents and receive full credit. Please contact us at nhfirs@dos.nh.gov.

We continue to work with the team at the Fire Academy as departments implement the NHESR program, available free of charge, for incident reporting. If you are interested in having a presentation on the program or would like to request one, please email MHESR@dos.nh.gov.

In May, the U.S. Fire Administration (USFA) announced their effort to launch a new fire information and analytics platform, known as the National Emergency Response Information System (NERIS), for the American fire and emergency services. Please find more information here: Media Advisory: USFA Announces New Fire Information Platform (fema.gov). Once NERIS is developed and operational, USFA will work to migrate fire and emergency services departments onto the new platform. The legacy NFIRS will remain operational throughout the transition process so all fire and emergency services departments should continue to use the current NFIRS data system and maintain status quo until migrated to the new platform. The latest NERIS webinar, *Understanding the Proposed NERIS Data Framework*, was held on December 14, 2023. This one hour session highlighted the project's advancements, key attributes of the new framework, opportunities to offer feedback, and tangible benefits the system will offer to first responders, agencies, and the public. In addition, the USFA and FSRI have announced a 30-day national engagement period for the NERIS Draft Data Framework. During this critical phase, they are seeking input on the newly developed data schemas that make up the Framework. These schemas, which are integral to the operations of NERIS, include a Fire Department Specification schema, a Computer-Aided Dispatch

(CAD) schema, and an Incident Data schema. Your input is sought after reviewing the Core NERIS Data Framework and schemas. Please find the Draft NERIS Data Framework, schemas and access to the Feedback Form here:




Outreach Events:

Personnel

- ➤ The open Fire Service Instructor Supervisor position in the Bureau of Certification and Support remains open. We have updated the job description and have advertised the position.
- ➤ We have one vacancy for Program Specialist III (Education Technologist) of the Educational Technology section of the Division and we will be reviewing candidates and scheduling interviews.
- ➤ We have a Program Assistant I position open and the internal advertisement is closed. We will be reviewing candidates and scheduling interviews.
- ➤ We continue to advertise for our three new full-time Fire Training Instructors.
- ➤ We have one part-time Compliance Specialist position open and interviews will begin this month.
- ➤ We have made a conditional offer for the part-time EMS Vehicle Inspector Coordinator position.
- ➤ Our part-time Program Coordinator position for Fire Officer is open and we are seeking applicants.
- ➤ Captain Kathy Higgins-Doolan has announced her retirement from the Division. Kathy has dedicated over 31 years of service to the EMS system in New Hampshire. Please join us in wishing her a healthy and happy retirement.

Grants

- ➤ The architectural firm retained for the Raymond S. Burton Fire and EMS Training Facility project has finalized the construction documents.
 - The RFP was opened December 12th and closes this month.
- ➤ The Department of Health and Human Services Covid Disparities Funding program we are seeking funds from will allow us to expand Image Trend to add Continuum, additional IFT, MIH and simulation training and staff support. We are working this through Governor and Executive Council for their approval.
- ➤ The NH EMT Training Program remains active with grant funding for training new and existing EMS providers. Contact our Division or NH Employment Security for details and question.

Special Projects

- We are working on our website transition and improvements with NH DoIT.
- ➤ We are working on WiFi improvements to better support students and guests at our Concord campus in the Administration building, Dormitory, Fire Station and ARFF classroom. These upgrades are planned to be completed in January.
- The Law Enforcement Officers, Professional Firefighters and Emergency Medical Technicians Career Development, Recruitment and Retention Program committee established in New Hampshire RSA 188-F:70 announced the new program on December 18th. Details can be found on our website under the Recruitment and Retention link from the homepage.
- > The Education Technology section is working to update the online Narcan for First Responders course, the Hazardous Materials course, Firefighter I and II modules and enhance the continuing education courses. Work is also being done for the new protocol rollout later this quarter.
- ➤ We have begun researching Immersive Learning (virtual reality, augmented reality, etc) for firefighter training with both private vendors and SNHU.
- > We will be partnering with the International Society of Fire Instructors to bring their *Water Mapping* program to the fire academy. Part of this project will be constructing the prop, offering a train-the-trainer program and then a student offering of the class this summer.

Facilities

- We are working to have an inspection done of the "A" building by the manufacturer.
- The replacement of two AC condenser units in the older portion of the dormitory building will be completed this winter after receiving final approval this month.

Legislative/Administrative Rules

- ➤ The Fire Standards and Training Commission amended Fire rules relative to the Recruitment and Retention report and its recommendations are working through the internal legal process in preparation for submission to the Joint Legislative Committee on Administrative Rules (JLCAR) which will include public input.
- ➤ The Educational Training Agency ruleset (Saf-C 5900 EMS) continues to be facilitated through the JLCAR process.
- > The proposed Trauma Rules are working through the internal legal process.

- SB 407 Relative to Direct Pay for Ambulance Services
- SB 409 Relative to Reimbursement for Ambulance Services Under the State Medicaid Plan

Outreach

- ➤ We are continuing our Leadership Roundtables with the Commissioner, Fire Marshal's Office, HSEM and Emergency Services and Communications with regional Fire Chief's and EMD's.
 - We are planning outreach meetings at Souhegan Mutual Aid and in the north country for early 2024.
 - Our Division representatives will be attending the Lakes Region Chief's meeting in January.

Mental Health & Resiliency

- ➤ The 2024 Mental Health & Wellness Seminar will take place at the NH Fire Academy in Concord, NH on January 17-18, 2024.
 - Day one will have two full group sessions and two separate breakout sessions with various topics being presented for attendees to choose from. Day two will include a presentation of Primex's play titled "The Aftermath" with a panel discussion following.
- ➤ Trauma Informed First Responder Training Concord campus February 28th
- ➤ We continue our work in partnership with the Police Academy to develop a more comprehensive program for PTSD training utilizing experts from this field in development of the curriculum and delivery. We are working through the Governor and Executive Council process for approval and acceptance of the funding to begin the project.
